SRDG/ORAU AFFILIATION TO TERMINATE

At the winter meeting of the Executive Committee at Oak Ridge, on March 6-7, it was decided by mutual agreement of the elected members of the Executive Committee and Phil Johnson, executive director of ORAU, to move towards formal disaffiliation of the two organizations. This step is being taken in light of SRDG's maturity as a professional organization and strong financial position. This disaffiliation should be completed by the end of the calendar year.

As a consequence of this decision, several steps will have to be taken; pri-

mary among them are the adoption of a formal constitution for SRDG and the subsequent incorporation of the organization as a not-for-profit corporation. A committee to form a constitution and articles of incorporation has been appointed: it includes present members of the By-Laws revision committee (Anne Lee, Abbott Ferriss, Mohamed El-Attar), President Bowles, Vice President Espenshade, Secretary-Treasurer Serow, and V. Jeffery Evans of the National Institute of Child Health and Human Development. The committee will draft a constitution and circulate copies to the membership during the summer. Any comments or suggestions which are appropriate will be included in the final document which will be presented to the membership for ratification at the annual business meeting in Tallahassee next October.

It should also be noted here that the Executive Committee unanimously approved a resolution calling upon President Bowles to express to ORAU the appreciation of ORAU's critical assistance in the formation of SRDG and for the invaluable support given to SRDG by ORAU over the past decade.

EXECUTIVE COMMITTEE MEETS AT OAK RIDGE

In addition to the question of the formal disaffiliation of SRDG and ORAU (see story elsewhere in this issue) several other issues were discussed at the Executive Committee's winter meeting. The secretary-treasurer reported a current unencumbered balance of \$3,338.30 (\$2500 in Fidelity Cash Reserves Fund; \$838.30 in checking at National Bank & Trust of Charlottesville); current paid membership

stands at 317. The committee authorized the expenditure of \$200 for the preparation of a subject index for *The Population of the South* (see February *Newsletter*). Vice President Espenshade reported that an informal survey of the membership showed little support for continuation of the occasional paper series. The series has not been discontinued, but at present there are no plans for any additional papers.

Plans for the 1980 meeting are progressing well; local arrangements chairman Charles Nam has arranged a fish fry dinner as part of the meeting. Details on the dinner and other aspects of the meeting will be provided members in a special mailing to go out in June or July. There will also be an informal abstract booklet prepared this year — it will be included in the registration packet for those attending the meeting; others will be able to procure a copy for a nominal charge. Finally, the 1981 meeting has been tentatively scheduled for the Little Rock (Arkansas) Hilton on October 14-16. Forrest Pollard chairs the local arrangements committee.

SOUTH CLOSING FACULTY SALARY GAP WITH NATION

Southern states are closing the faculty salary gap with the nation, according to a recent study by the Southern Regional Educational Board. Between 1974 and 1979, salary increases for faculty in public institutions in the South have averaged about 1½ to 2 percent higher than in other regions combined, which has decreased the gap between average salaries in the nation and the South. In 1974, salaries in the South were 16 percent lower than in the rest of the nation; by 1979, the Consumer Price Index grew an average of almost 8 percent yearly, while annual salary increases for Southern faculty averaged 7 percent, versus 5 percent elsewhere. For public, four year institutions, the regional average salary was \$19,440 for the academic year, in 1978-79. STANDARDIZED POPULATION PROJECTIONS REQUIRED

A new policy on the development and use of population projections when agencies use projections for the allocation of federal funds is being developed by the Department of Commerce and the Office of Management and Budget. In recent years, a growing number of federal agencies have begun to use population projections as a factor in distributing funds. There has been, to date, no coordination of the use of these projections. As a result, projections from a variety of sources have been used. For distributing funds to the same geographic area, various federal agencies have used projections from different federally-generated series, or, more commonly, from series produced by state or local governments. Even in state and local governments, different series are produced by different agencies for use in applying for various federal funding programs. FERTILITY SURVEY TAPES RELEASED

The Data and Program Library Service of the University of Wisconsin-Madison announced the release of the public use versions of *American Family Growth, 1957-67* and of the National Fertility Study 1975. Both of these are well-known micro level sources of data on reproductive history and the correlates of the ends, means, and conditions which determine fertility. The cost of *American Family Growth* (with documentation) is \$143; that of the National Fertility Study (with documentation), \$127. CENSUS ANALYSIS WORKSHOP

A national workshop on planning effective publications and presentations on the 1980 Census will be conducted in Madison, Wisconsin on June 30-July 1. The workshop is designed for the staff of organizations which prepare and disseminate
