## NEWS ITEMS

### NEW BOARD OF DIRECTORS

Abbott Ferriss of Emory University and Clifford Patrick of the National Heart, Lung, and Blood Institute were elected to three year terms on SRDG's Board of Directors (formerly the Executive Committee) in this year's election. They will occupy the places on the Board held by Gladys Bowles and Ronald Rindfuss. In related developments, Thomas Espenshade of the Urban Institute was elected as president of SRDG and chairman of the Board with Calvin L. Beale of the U.S. Department of Agriculture being elected as vice-president/vice chair. Continuing on as members of the Board are William Serow of the University of Virginia (secretary-treasurer), Larry Long (Census Bureau), and Ken E. Shin (University of South Carolina).

With the ratification of SRDG's new constitution and by-laws it will be necessary to conduct a special election at this time to fill the position of president-elect. A nominating committee comprised of Gladys Bowles, George Myers, and Harold Goldsmith has nominated Anne S. Lee of Athens, GA and Abbott L. Ferriss of Emory University to stand for election to this position. Under the provisions of the new constitution and by-laws, the person elected to this position will serve as president-elect until the 1981 business meeting, as president from then until the 1982 business meeting, and as past president from the 1982 to 1983 business meetings. A ballot for voting in this election is enclosed with the *Newsletter*.

### ANNUAL MEETING REPORT

SRDG held its 11th annual meeting on October 15-17 in Tallahassee, Florida. Approximately 145 members and guests attended the meeting. For the benefit of any members unable to attend, a very limited supply of programs and abstract booklets are available from the secretary-treasurer (W. Serow, TMI, P. O. Box 6550, Charlottesville, VA 22906).

In addition to the approval of SRDG's new constitution and by-laws, the changes in the composition of SRDG's Board of Directors, and the nomination of two members to run for the office of president elect (see story elsewhere in this issue), numerous other items of business came before the Board. The secretary-treasurer reported that prior to the meeting there were 362 persons on the membership roster, 228 of whom had paid dues for 1980. More recent additions have brought these numbers to 399 and 287, respectively.

Harold Goldsmith reported that the joint PAA-SRDG committee on the establishment of a federal register for demographers had succeeded in persuading the Bureaus of the Census and of Labor Statistics to negotiate with the Civil Service Commission on this register. Abbott Ferriss, SRDG archivist, reported a large supply of SRDG's occasional paper no. 1, ("Perspectives on State Demographic Activities") and much smaller quantities

of other publications ("Research and the 1970 Census," "Labor in the South," and "The Demography of the South") were available through his office. Copies of "Perspectives" are available for \$2.00, others are complimentary. Please address inquiries to: Dr. Abbott L. Ferriss, Department of Sociology, Emory University, Atlanta GA 30322. First come, first served.

The Board appointed a membership committee comprised of: Chris Hale (chair), University of Alabama-Birmingham; George Dailey, city of Oklahoma City; Jim Zuiches, National Science Foundation; Don Belcher, Nashville Area Chamber of Commerce; Chuck Longino, University of Miami; and Cheryl Russell, *American Demographics*. The committee will work with the Board not only to promote SRDG membership but also to insure that the organization is fully responsive to the needs and interests of all members.

The Board gave conditional approval to a request by George Myers (Duke University) for limited support of a membership survey to inquire about member's perceptions of the needs for various types of demographic training in the 1980's and their opinions about the adequacy of past training efforts. The survey may also be utilized to obtain input for a new edition of SRDG's membership directory.

Meeting sites for 1982 and 1983 have also been selected: the 1982 meeting will be held in Greensboro, NC (local arrangements chair: Daniel O. Price); the 1983 meeting will be in Chattanooga, TN (local arrangements chair: Edward E.

Cahill). As previously announced, next year's meeting will be held in Little Rock, Arkansas on October 14-16. Forrest Pollard chairs the local arrangements committee.

Finally, the Board authorized President Espenshade to write a letter offering SRDG support to ongoing activities of the Oklahoma Demographics Group.

RPDU is an interdisciplinary journal publishing articles and research notes concerned with the production, collection, use, and policy implications of public data. Recent issues have included articles on the methodology of both estimates and projections, an analysis of worker mobility, the impact of federal controls and regulations on research, and problems encountered in using various data sources.

## NONMETRO HOUSEHOLD COMMUTING PATTERNS

A recent report produced by the U.S. Department of Agriculture and the University of Georgia examines the characteristics and rates of inter-county commuting for employment of migrant and nonmigrant household heads living in nonmetro areas in 1975. It also deals with the extent to which migrants continue in employment in the type of areas in which they lived five years earlier. Comparative data are included for heads of household residing in metro areas. The research was based on the 1975 Annual Housing Survey and its Travel-to-Work Supplement. The Applied Population Laboratory of the University of Wisconsin announces the publication of *Reference Tables: Net Migration of Those Aged 0 to 64 and 65 and Over for United States Counties, 1970 to 1975*. The report was written by Stephen J. Tordella and provides estimates of net migration for two broad age groups during the first half of the 1970s. It should prove of great interest to those charting the nonmetropolitan population growth turnaround and other migration trends, especially those affecting the elderly. ## NIMH PLANS 1980 SMALL AREA INDICATORS

Data users who find indicators for census tracts and other small areas valuable in their work should note that the National Institute of Mental Health is planning an update of its Mental Health Demographic Profile System based on 1980 census results. The 1980 system will offer over 100 indicators calculated from census data for all tracts, minor civil divisions, counties, and selected other areas throughout the country. ## EDUCATION FOR HISPANIC AMERICANS

The National Center for Education Statistics (NCES) has recently published a major report entitled *The Condition of Education for Hispanic Americans*. The report consists of a compilation and discussion of available data concerning the educational achievement and participation of Hispanic Americans. Separate chapters are devoted to an overview of Hispanics in the United States, Hispanic participation in elementary and secondary education, Hispanic participation in postsecondary education, and outcomes of education. ## NATIONAL PENSION POLICY REPORT

The President's Commission on Pension Policy has made public an interim report of the Commission which has been presented to the President and to Congress. ## NATION'S USE OF HEALTH RESOURCES

The second edition of *The Nation's Use of Health Resources*, published by the National Center for Health Statistics, presents current and comprehensive data on the use of health care systems in the United States. The information in the report has two essential uses: to represent current knowledge about health care utilization and to identify those areas in which systematic data collection on a consistent basis are required. ## SECOND SERIES OF "POPULATION PROFILES"

The Center for Information on America has announced plans for its second series of Population Profiles. The first series consisted of 17 units, each

focused on a special aspect of population in the United States. The second series is patterned on the first, but emphasizes an international approach. The second series is being undertaken in cooperation with the Population Reference Bureau; the first two numbers in the second series ("Why Study World Population" by Everett S. Lee and "The Population of China" by Leon F. Bouvier) are now available. Future numbers in the series will deal with India, Africa, the Soviet Union, Latin America, Europe, the Middle East, and other topics. ## POPULATION FELLOWSHIPS

The Population Council has announced its fellowship program in the social sciences for 1981-82. Fellowships will be awarded for advanced study in population at the graduate, post-doctoral, or mid-career levels. Strong preference in making the awards will be given to applicants from developing countries who have a firm commitment to return to their home country upon completion of training. ## STATISTICAL PORTRAIT OF WOMEN

The Bureau of the Census has recently released a report entitled "A Statistical Portrait of Women in the United States: 1978." This report provides a statistical overview of the changing status of women in American society during the decade of the 1970s. Data were compiled from U.S. Government sources, including surveys, decennial censuses, vital statistics, and administrative records. Comparisons of black women with white women are discussed separately and recent data are included for women of Spanish origin, as well as American Indian and Asian-American women. ## 1980 DATA FROM DUALABS

DUALabs has announced the formation of the File Reduction Consortium which will develop procedures to permit reduction of census files and records, regardless of tape density. For 1970 census files, an average reduction of 83 percent was accomplished; the use of counts 1 to 5 from the 1970 census would have saved a user interested in acquiring tapes for the entire nation the sum of about \$50,000.
