MICROCOMPUTER WORKSHOP SET FOR AUSTIN MEETING

An interesting workshop, "An Introduction to Microcomputers for Demographers", will be conducted on Wednesday, October 16, prior to the SRDG annual meeting in Austin from 1:00-5:00 p.m. The workshop is sponsored by the Applied Demography Committee of SRDG. The two major purposes of the workshop are: 1) To provide a non-technical introduction to microcomputers which emphasizes features of special interest to demographers; and 2) To demonstrate the use of some alternative hardware systems and software packages that members of SRDG have found useful.

The workshop will cover the following topics: fundamental concepts, alternative systems (costs and acquisition), programming languages, personal computer software, statistical software (SPSS, EPSTAT, STATPRO, SYSSTAT), mapping and graphics, communications with computers, and special demographic applications. The program is still being developed, and the organizers would welcome your suggestions on content to meet the needs of SRDG members. Anyone who would like to make a presentation or demonstrate the use of products within the scope of the workshop is encouraged to contact one of the organizers as soon as possible.

MICROCOMPUTERS AND ECONOMIC ANALYSIS: SPREADSHEET TEMPLATES FOR LOCAL GOVERNMENT, by Neil Sipe and Robert Hopkins; \$12.50. This monograph illustrates how microcomputer spreadsheets such as Visicalc, Lotus 1-2-3, and Multiplan can be used to perform routine analyses for local governments. The monograph includes 15 spreadsheets, the formulas used for computations, and a discussion of the methodology. Chapters include: population projections, revenue projections, economic base analysis, fiscal impact analysis, government budget analysis, pricing public services, determining capital costs and impacts, and other analytic techniques. TRANSPORTATION FOR THE POOR: RESEARCH IN RURAL MOBILITY, by Hal S. Maggied. Kluwer-Nijhoff Publishing, Boston, MA. One of the Studies in Applied Regional Science, this book has six chapters dealing with the economic and social problems of the rural poor in obtaining and utilizing transportation, including a chapter using Georgia as an example.

HEALTH: UNITED STATES, 1984. NCHS, Hyattsville, MD. This annual volume is full of the latest vital statistics and other health data from the numerous resources of NCHS. This year's issue highlights state variations for a number of health indices. No demographer should be without access to this compendium of health data.

IMPROVING NATIONAL STATISTICS ON CHILDREN, YOUTH, AND FAMILIES. Child Trends, Inc. 1990 M St. NW, Washington, DC 20036. Free on request. This 2-volume report discusses the recommendations of the Interagency Conference on Child and Family Statistics held at NIH in April 1984. Part 1 is a summary prepared by Child Trends, and Part 2 contains the detailed recommendations made by each issue group at the Conference.

Also, **NATIONAL STATISTICS ON CHILDREN, YOUTH, AND FAMILIES: A GUIDE TO FEDERAL DATA PROGRAMS.** \$12.00 from Child Trends. This-164 page report describes more than 40 major data collection programs, the child and family descriptors available in each, and where to obtain reports and data tapes produced by the program.

The Census Bureau is planning a test census in Mississippi early in 1986, in preparation for the national census in 1990. The test will cover the east central counties of Attala, Jasper, Kemper, Lauderdale, Leake, Neshoba, Newton, and Winston, and the Choctaw Indian Reservation. The area is essentially rural and thus is suitable for testing ways to improve delivery of questionnaires to residents in sparsely populated areas. The bureau also wants to improve enumeration of the American Indian community. The agency plans to evaluate new procedures for coverage and automation in Mississippi that could improve accuracy and reduce costs in 1990. The test will require hiring several hundred temporary workers and add about \$800,000 to the local economy.

ANNUAL HOUSING SURVEY DATA AVAILABLE

The Annual Housing Survey (AHS) 1983: Part A, General Housing Characteristics (USGPO, \$7.50, 1984) and Part C, Financial Characteristics (USGPO, \$9.50, 1984), are available to examine the characteristics of housing units and their occupants.

The AHS Data Project staff of Abt Associates facilitate use of the AHS and are available to help demographers to take advantage of this data set. Among the recent information available are a codebook for the Annual Housing Survey Data Base and a questionnaire directory and frequency counts for Annual Housing Survey Data Base. The Data Archive on Adolescent Pregnancy and Pregnancy Prevention (DAAPPP) can aid SRDG researchers. DAAPPP has acquired 7 new data sets from the Western Washington Archive on the antecedents of teenage pregnancy which will become available upon processing and documentation. 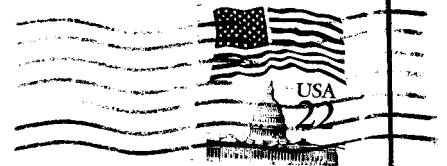
